



IRA DONATIONS

The provision known as the “charitable IRA rollover provision” has been reinstated for 2015, and made permanent for future tax years.

Here is how a charitable gift IRA rollover works –

If you are 70 ½ years of age or older, you may make a distribution from your IRA for up to \$100,000 to a church or charity of your choice.

The funds must go directly from your IRA trustee payable to the church or charity to qualify for a tax-free rollover. While there is not charitable deduction for you, the tax-free rollover will not count as income to you but will count towards your annual required minimum distribution (RMD).
